## Vigilance Circular 1/2023

Sub.: Observance of "Vigilance Awareness Week (VAW) -2023" Ref.: CVC Circular No.06/08/23 dtd. 2<sup>nd</sup> Aug 2023.

The Central Vigilance Commission vide its circular No. 06/08/23 dtd. 2<sup>nd</sup> Aug 2023 has informed that this year, the "Vigilance Awareness Week-2023" would be observed from 30<sup>th</sup> October to 5<sup>th</sup> November, 2023.

- 2. As a prelude to Vigilance Awareness Week 2023, the Commission has directed to undertake a three-month campaign (16th August 2023 15th November 2023) with the following Preventive Vigilance measures as focus areas:
  - a. Awareness building about Public Interest Disclosure and Protection of Informers (PIDPI) Resolution,
  - b. Capacity Building programs,
  - c. Identification and implementation of Systemic Improvement measures,
  - d. Leveraging of IT for complaint disposal,
  - e. Updation of Circulars / Guidelines / Manuals,
  - f. Disposal of complaints received before 30.06.23.
- 3. The prelude to VAW 2023 commences from 16th Aug 2023 and concludes on 15th Nov 2023. The list of activities as mentioned in the CVC Circular shall be conducted in the IMU Hqrs/ all the Campuses in letter and spirit during these three-month periods. Active & effective participation of all the employees of IMU is mandatory. Vigilance Coordinators are requested to devise a suitable provisional budget for organizing the events well in advance for the seamless conduct of activities.

- 4. The Campus Directors and the Vigilance Coordinator of Hqrs are requested to prepare an action plan for three-month campaign period as directed by the CVC and submit the same to the O/o CVO, IMU positively before 21.08.2023 without fail.
- 5. The Vigilance coordinators / Campus Directors are requested to place billboards of permanent nature, perpetually at entrance of the precinct and at potential spots containing the content provided at page No. 5 of the CVC's Circular referred above.
- 6. The IT section of the IMU Hqrs/respective campuses must display information about the observance of Vigilance Awareness Week-2023 in the official website(s) and social media handles.
- 7. The Campus Directors and the Vigilance Coordinator of Hqrs are requested to implement the various provisions of the CVC Circular and submit the action taken report in the format C(i) C(vi) enclosed with this circular so as to reach the CVO by  $28^{th}$  Nov 2023.
