Clause 68.16	Due to Covid-19, an amount equivalent to 3% (three percent) on the monthly bills during the contract period will be retained towards Security Deposit for due performance of the Contract and the same shall be returned on completion of 60 days beyond the date of the completion of all contractual obligations without any interest.		It was informed that due to Covid 19, an amount equivalent to 3% on the monthly bills during the contract period will be retained as Security Deposit, however, as and when, the Covid-19 is completed, 10% on the monthly bills during the contract period will be retained as per GFR.
6.	Clause 20	The Price Bid, shall be opened only in respect of tenderers who were qualified in the Technical Bid. After evaluation of the Price bid, IMU would intimate the award of Contract to the successful tenderer. The successful tenderer shall enter into an agreement / a Contract covering the entire scope of services with IMU within <u>one</u> week from the date of award of the work.	The bidders stated that after placing on order on the successful bidder, they require a time period of two to three weeks for commencing the mess activities.	The Purchase Committee informed that a two week time shall be given for commencing the mess activities upon placing the order.
7.			The bidders wanted to know the payment to be made during the vacation period.	During vacation, one cook and two assistants are to be available for the preparation of tea, snacks, lunch and dinner for its employees and guests. During this period the minimum wage as applicable shall be reimbursed to the cook and two assistants for carrying out the
