B. TECH. (MARINE ENGINEERING)/ B.Sc. (NS), DNS

Candidates joining B.TECH., (MARINE ENGINEERING)/ B.Sc. (NS), DNS AT IMU, CHENNAI CAMPUS are requested to bring the following original Certificates along with copy of certificates/ Documents during the admission process for verification and submission (AY 2020-21)

- f) Printed copy of IMU's Rank Certificate
- g) Medical Fitness Certificate (DGS approved Doctor)

B.Tech: Distance Vision unaided 05* (6/12) in each eye or 0.67 *(6/9) in one eye and 0.33*(6/18) in another eye.

BSc, DNS: Eye sight 6/6 in each eye or 6/6 one eye & 6/9 in other (No colour blindness in eye)

- i) Passport (If not available, apply immediately on Tatkal)
- j) Passport Size photos (08 Nos.) (Front view with both ears visible in light colored shirt with dark background)
- k) One set of self-attested copies of all documents
- l) Domicile certificate for candidates allotted seats reserved for North Eastern States, J & K, Andaman & Nicobar Islands and Lakshadweep Islands

Selected candidates should preserve enough numbers of attested copies of the documents and certificates (for their own use) before submitting the originals to IMU Chennai Campus. The original documents/certificates submitted will be returned to candidates only after completion of the admission process.

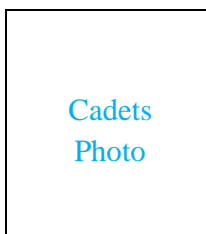
