## B. TECH. (MARINE ENGINEERING)/ B.Sc. (NS), DNS

Candidates joining B.Tech (MARINE ENGINEERING)/ B.Sc, (NS), DNS at IMU, CHENNAI CAMPUS are requested to bring the following original Certificates along with a copy of certificates/ Documents during the admission process for verification and submission (AY 2023-24)

- g) Medical Fitness Certificate (DGS approved Doctor)

BSC, DNS: Eye sight 6/6 in each eye or 6/6 in one eye &6/9 in the other eye (No colour blindness in the eye)

- i) Passport (If not available, apply immediately on Tatkal)
- j) Passport Size photos (08 Nos.) (Front view with both ears visible light-colored shirt with dark background)
- k) One set of self-attested copies of all documents
- I) Domicile certificate for candidates allotted seats reserved for the North Eastern States, J & K, Andaman & Nicobar Islands, and Lakshadweep Islands
- m) PASSPORT is Mandatory prior joining the college.
