Sub: Online Common Entrance Test (CET) – DNS Programme at Affiliated
Institutes for Sponsored Candidates - February 2019 Batch - reg.

Admissions to courses conducted in IMU Campuses and Affiliated Institutes are done through an All-India Online Common Entrance Test (CET). For the year 2019, the Computer based CET is to be conducted for admission to DNS February 2019 batch in the following seven Affiliated Institutes to be held in 12 cities across India on **Friday, 4th January 2019**.

1. Anglo Eastern Maritime Academy, Mumbai.
2. Applied Research Institute (ARI), New Delhi.
3. International Maritime Institute, Greater Noida
4. Maritime Training Institute (SCI), Mumbai
5. Samundra Institute of Maritime Studies, Mumbai
6. The Great Eastern Institute of Maritime Studies, Mumbai
7. The Training Ship Rahaman, Mumbai.

1. The entire spectrum of activities -from the registration of applications to the publication of results, being done online by Ms. NSEIT- the Service Provider. The CET for admission to DNS (Sponsored Candidates only) Feb 2019 batch will be held between 10 am and 1pm on Friday, **4th January 2019 in 12 cities all over India**.
2. The Online registration for the Candidates to register and pay the fees will be open from **14th December 2018**. The last date for the online registration of applications is **24th December 2018**.

3. The timeline for the admissions to DNS February 2019 Batch and related activities is shown below:

4. The Syllabus for the Online CET for DNS, February 2019 batch will be as follows:

- No. of Questions – 200 multiple choice questions.
- Syllabus - English, General Aptitude, Physics, Chemistry, Mathematics at Plus Two level.
- There will be no negative marking for wrong answer.

5. Kind attention of all affiliated Institutes is drawn to Section 5, sub-sections (xxvii) and (xxxiii) of the Indian Maritime University Act, 2008 read with Chapter VII of Ordinances Governing Academic Matters as published in the Gazette of India Extraordinary on 12th May 2009 according to which no student shall be eligible for admission to any UG or PG course in the IMU unless he has passed the exam or exams prescribed by the University. Passing the CET conducted by the IMU is one of the essential eligibility criteria for admission, along with criteria relating to age, marks in plus 2 exams, medical fitness, etc., No Affiliated Institute shall therefore, make any admissions of students (including sponsored/management candidates) unless they have qualified in the CET January 2019. It may be noted that if any candidate is admitted without qualifying in CET January 2019, he will neither be given admission registration number nor will he be allowed to appear in any of the scheduled examinations of IMU.

This Circular issues with the approval of Competent Authority. With regard to data entry, payment of admission registration fees in the Online Portal and certificate verification will be issued in separate Circular in due course. .
