Sub:Online Common Entrance Test June 2019 for admission to various Programmes of IMU- reg.

1. Admissions to various Programmes conducted in IMU Campuses and Affiliated Institutes are done through an All-India Common Entrance Test (CET). This Common Entrance test (CET) for admissions to various programmes for the Academic Year 2019-20 will be done online mode.
2. The advertisement for online CET for admissions to all UG and PG courses offered by IMU and its Affiliated Institutes for **August 2019** published on 01-04-2019 in leading newspapers in Hindi, English.
3. The Online registration for the Candidates to register and pay the fees will be open from **01-04-2019 to 05-05-2019**. The last date for the online registration of applications (other than BBA Programme) is **08-05-2019**.
4. The entire spectrum of activities -from the registration of applications to the publication of results is being done online by M/s National Stock Exchange -IT the Service Provider. This year's CET will be held **between 11.00 am and 2.00 pm on SATURDAY, 01st June 2019 in 36 cities all over India.**

There will be no online Common Entrance Test for B.B.A (Logistics, Retailing and E-Commerce) Programme, however candidates have to register online in the link provided by IMU. 50% seats of M.Sc (Commercial Shipping and Logistics) has been reserved for Seafarers holding Master (FG) or MEO Class I Certificate of Competency for which there will be no CET. Eligible and interested seafarers have to send e-mail to the Controller of Examination (coe@imu.ac.in) [Subject: Admissions to M.Sc(CSL) Programme -Seafarers]. Non-Seafarers will be admitted through IMU's online CET.
6. *Admission to BBA (Logistics, Retailing and E-Commerce) programme*
- There will be **NO** CET for admissions to this programme.
 - Online registration for the Candidates to register and pay the fees will be open from **01-04-2019**. The last date for Online Registration for these candidates is **Wednesday, 5th June 2019 till 11.59 PM**.
 - These candidates must update their status and enter their Class 12 Exam marks and upload a scanned copy of Class 12 Exam Mark Sheet as and when they are published, subject to the last date indicated above. Online Registrations for which Class 12 Exam marks have not been entered and scanned copy of Class 12 Mark Sheet has not been uploaded will not be considered for admissions.
 - These candidates are advised to register online first, choosing the 'Awaiting Results' option, and update their Class 12 Exam marks and upload their Scanned copy of Class 12 Exam Mark Sheet, later using the 'Edit' option. This 'Edit' option will be available from **Wednesday 15th May 2019 to Wednesday, 5th June 2019 till 11.59 pm**.
 - Candidates who have registered online for the "Common Online CET for all UG Programmes (except BBA)" must register online separately for the BBA (Logistics, Retailing and E-Commerce) programme, if they are also interested in the latter, and must pay the Registration Fee for both.
