Sub.: Observance of "Vigilance Awareness Week (VAW) -2022"

Ref.: CVC Circular No.20/09/22 dtd. 8th Sept 2022.

The Central Vigilance Commission vide its circular No. 20/09/22 dtd. 8th Sept 2022 has informed that this year, the "Vigilance Awareness Week-2022" shall be observed from 31st October to 6th November, 2022. The theme for this year is "**Corruption free India for a developed Nation**".

The following list of indicative activities shall be exercised during the Vigilance Awareness week 2022, however it is not exhaustive:

1. The pledge (copy enclosed), shall be taken by all officers/teaching faculties/ staff/ students at their respective campuses and the same would be administered by the Campus Director of the respective campus at 11 a.m. on 31st October, 2022. The Registrar, IMU may administer the oath for the officers /staff of Hqrs. on 31st Oct 2022 at 11 a.m.
2. Display banners as below shall be placed at prominent locations so as to attract the attention of all the stakeholders of IMU.

3. Vigilance Coordinators are to devise a suitable provisional estimate budget for organizing the events well in advance for the seamless conduct of events.
4. Essay writing competition shall be conducted during the Vigilance Awareness Week.

5. The prize money for the essay competition as per extant procedure shall be as follows:

	Ten Consolation Prize – Rs.500/- each

Participation Certificate shall be given to all participants.

6. The IT section in the respective campuses must display information about the observance of Vigilance Awareness Week-2022 besides providing hyperlink to subscribe for e-pledge in their respective websites.
7. The Accounts section in the respective campuses must display the slogan '**Corruption free India for a developed Nation**' in the printed pay slips/ e-pay slips to be issued for the month of October & November 2022.
8. The Vigilance coordinators shall be the nodal officers for effective and smooth conduct of the VAW-2022 and are encouraged to carry out other activities as mentioned under point Nos. 7 & 8 of the above referred circular of CVC.
9. A report along with selected photographs on the observance of "Vigilance Awareness Week 2022" shall be sent to the O/o CVO on or before 22nd Nov 2022 in the format-2 enclosed for further necessary action.
