Addendum to the CIRCULAR - 2309

<u>Sub: -</u> Campus Nodal Officers – Inland Vessel (IV) training – regarding.

- 1. Please refer to the Circular 2309 dated 22.05.2023 on adaptation of Inland Vessel (IV) training modules (prepared by IMU) by State Maritime Boards (SMBs), wherein, it has come to IMU's light that Inland Waterways Authority of India (IWAI) shared IV course modules with SMBs & State IWT Departments and requested them for adopting unified IV training modules (prepared by IMU) for imparting IV training and subsequently, the Cicrular-2309 has been issued to all Campuses of IMU under intimation to SMBs with a request to Campuses to approach the SMBs for starting IV courses (only after giving intimation to IMU-HQ).
