IMU-HQ PROCUREMENT CIRCULAR NO. 05/2023

Sub: Implementation of Clause 13A of "Public Procurement (Preference to Make in India) Order, 2017"- Reg

Ref: MoPSW letter no. SY-13017/4/2017-SBR, part3 dated 16 Aug 2023

1. Vide cited above reference (copy annexed for ready reference), the Ministry has issued notification on implementation of Clause 13A of Public Procurement (Preference to Make in India) order, 2017 with respect to procurement of all goods, services or works in respect of which there is substantial quantity of public procurement and for which the nodal ministry as not notified that there is sufficient local capacity and local competition.
2. The items as listed in the referred letter are notified as shipbuilding/repair items for which the procuring entities, while procuring these items beyond the notified threshold value, shall prescribe in their respective tenders that foreign companies may enter into a joint venture with an Indian company to participate in the tender.
3. Such joint ventures will be exempted from meeting the stipulated minimum local content requirement and it shall be increased in a phased manner.
4. Forwarded for information and implementation by all concerned.

NOTIFICATION

Sub: Implementation of Clause 13A of "Public Procurement (Preference to Make in India) Order, 2017" with respect to procurement of all goods, services or works in respect of which there is substantial quantity of public procurement and for which the nodal ministry has not notified that there is sufficient local capacity and local competition

In pursuance of Department For Promotion of Industry And Internal Trade (DPIIT)'s Order No. P-45021/2/2017-PP(B.E.II) dated 15.06.2017 which was later amended on 16.09.2020, the following items are hereby notified as shipbuilding/repair items for which the procuring entities, while procuring these items beyond the notified threshold value, shall prescribe in their respective tenders that foreign companies may enter into a joint venture with an Indian company to participate in the tender:
