Admissions for February 2016 Batch – Conduct of CET – Reg.

It is proposed to conduct a Common Entrance Test (CET) on Saturday, 09 January 2016 between 2:00 pm and 5:00 pm, for admission to the DNS Programme February 2016 Batch. This CET will be applicable only to sponsored candidates of Affiliated Institutes. The notification for the CET will be published in the newspapers around 01 December 2015 and the Online Application will go live simultaneously.

All the Affiliated Institutes conducting DNS Programme February 2016 Batch have to make the necessary tie-ups for onboard training for the candidates to be admitted, with Ship-owning companies/ Ship-managing companies/ RPSL agencies before the above mentioned date. The number of slots for which the sponsorship is available should be forwarded to IMU on or before Tuesday, 15th November 2015 in the format prescribed on the Official Letter Head signed by the Authorised Signatory.

The Affiliated Institutes should acquire the necessary sponsorship letters from the Ship-owning Companies / Ship-managing Companies / RPSL Agencies on the Official Letter Head of the sponsoring Company /

Agency duly signed by the authority signatory, indicating the number of seats sponsored for that particular Institute. They should send photocopies of the sponsorship letters to the Controller of Examinations, Indian Maritime University, Chennai along with scanned copies of the sponsorship letters at coe@imu.co.in **No Affiliated Institute should make any admissions to DNS Programme without first obtaining these sponsorship letters.**

Please note that IMU may independently refer to the sponsoring Ship-owning Companies / Ship Managing Companies / RPSL Agencies the copies of the sponsorship letters to verify their genuineness. During 2014-15, IMU had occasion to detect a few fake sponsorship letters. It is hoped that such instances will not recur this year or in the future.

If any candidate is admitted in other than in the above mode, IMU will not allot Admission Registration Number to him and he will not be allowed to appear in any of the scheduled examinations of IMU.
