IMU will process such applications and even issue notices for Skill Test if the candidates are otherwise eligible. Unaided vision should be 6/12 in both eyes minimum or 6/9 in the good eye and 6/12 in the other eye minimum. Defective colour vision tested by ISHIARA test chart is a disqualification.
