

These trees were uprooted during the cyclonic weather.

Bidders must read the document carefully and should submit a copy of full tender document duly stamped and signed on each page by authorized signatory as a token of having read and understood the tender terms.
- 3. The bids in the prescribed Tender Document duly filled in all respect by the bidders must be submitted latest by 07.12.2020 up to 15:00 hrs. in the office of Deputy Registrar (Admin), Indian Maritime University, Navi Mumbai Campus.
- 4. The bids will be opened on the same date, i.e., 07.12.2020 at 1530 hrs in Audio Visual Classroom, Scholastic Block, in the presence of the committee members and bidders or their authorized representatives, if any.

TERMS & CONDITIONS FOR BIDDING OF DISPOSAL THROUGH AUCTION OF WOOD FROM FALLEN TREES/LOGS STOCKED IN THE INDIAN MARITIME UNIVERSITY, NAVI MUMBAI CAMPUS

- 1. The tenders must be submitted in a sealed cover duly superscripted "BID FOR DRIED WOODS/LOGS STOCKED IN INDIAN MARITIME UNIVERSITY, NAVI MUMBAI Campus" in the Office of Deputy Registrar (Admin), Indian Maritime University, Navi Mumbai Campus latest by 07.12.2020 till 1500 hrs. The bids shall be opened at 1530 hrs on the same day in Audio Visual Classroom, Scholastic Block, in the presence of Committee members and bidders or their representatives, if any.
- 2. The tenders shall be accompanied with an Earnest Money of Rs. 2000/- in the form of Demand Draft in the favour of "Indian Maritime University, Navi Mumbai Campus" payable at Navi Mumbai. The bids of the bidder, who fail to submit E.M.D, shall be summarily rejected. No exemption from payment of EMD is available to any bidder for any other reason whatsoever.
- 3. The wood from fallen trees/logs stocked in Indian Maritime University, Navi Mumbai Campus" can be inspected on working days (Monday to Friday) from 23.11.2020 to 04.12.2020, between 1500 hrs to 1700 hrs.
- 4. The estimated quantity of wood is about 11 Tons. The wood is from assorted trees mostly non furniture variety. Some of the photographs are appended at Annexure for better appreciation.
- 5. The vendor has to bid for per ton rate i.e. Rs----/Ton.
- 6. Initial payment from the successful bidder would be equal to Rate quoted x 11 Tons. If the quantity workout to be more additional payment would have to be made before removing additional wood. In case the quantity is less then excess amount worked out, the difference would be refunded within two working days of completion of removal of wood.
- 7. The Wood on removal from campus will have to be weighed at the nearest certified weighing bridge in presence of representatives nominated by the campus. The Weight report of weight taken in presence of Campus representatives will only be considered. The Empty truck weight is also to be taken in presence of campus representatives.
- 8. The successful bidder will have to lift entire wood available and shall not have the option of any segregation.



- 9. The party, whose bid is finally accepted, shall have to deposit the amount referred at Para 6 & 7 (after adjustment of earnest money deposited) within 7 days from the date of issue of the bid acceptance letter. If the amount is not deposited within the aforesaid period, the acceptance of offer shall stand cancelled and the earnest money shall be forfeited.
- 10. It will be the responsibility of the tenderer to remove/shift the goods from the Institute campus at their own cost & responsibility including trip to weighting bridge and weighting of wood.
- 11. After deposit of the balance amount as aforesaid, the party shall be bound to lift the woods/logs within 15 days from the University Campus. If the wood is not removed from the campus within stipulated date a notice will be issued to remove the wood. If the woods are not removed within subsequent 15 days, the Institute in such case shall be absolutely free to dispose of the woods in the manner it may deem appropriate as risk purchase option, i.e., if lesser payment is received compared to original bid the difference will be deducted from the deposit made.
- 12. The University reserves the right to reject all the bids without assigning any reasons and go for fresh disposal option. The decision of the Director in this regard would be final. Any incomplete bid is liable to be rejected.
- 13. The Price bid should be in a separate sealed envelope as per format given at Annexure III.
