Terms & Conditions:

- 1. Rate should be quoted including delivery & installation charges.
- 2. GST will be paid extra as applicable.
- 3. The total quantity for **Type I is 9** no's and **Type II is 33** no's approximately. However the final quantity shall be decided by IMU based on actual requirement.
- 4. The selected vendor should provide at least **one year warranty** for the product & services.
- 5. 5% of the awarded Contract value will be withheld as 'Performance Security' for a period of 1 year without any interest and shall be paid back after successful completion of such period.
- 6. The vendor should be capable of supplying any particular design, color and quality of the Roller Blinds on request from the IMU side.

8. Quotations should have a **validity of 90 days** from the date of submission of quotation.

9. Delivery and installation of the items should be completed within 2 weeks from the date of issue of Purchase order.

10.Payment shall be released only after satisfactory installation of the roller blinds as certified by the authorized person of IMU Kochi campus.

11.GST compliant invoice to be submitted. The GSTN of IMU Kochi Campus is 32AAI2610K1Z6. TDS as applicable will be deducted from the payment.

12. No advance payment will be done at any case.

13.University reserves the right to accept in part or in full any quote(s) or reject any one or more quote(s) without assigning any reason. The University also reserves the right to postpone the date of receipt & opening of quotation or to cancel the quotation without assigning the reason whatsoever.

14.Quotation received after the due date & time of opening of tender will be out rightly rejected. Quotations which are not as per the format will also be rejected.
