EMD will be refunded to all the unsuccessful bidders within one month from the date of issue of the Work Order. No interest will be paid on EMD. Quotations without EMD will simply be rejected. However, the quotation without EMD may be considered only upon submission of the valid MSME /NSIC Registration Certificate of the firm.

- 2. Bidders must submit the copy of certificate / license towards being OEM / Authorized Dealer / Distributor of the said Software along with their quotations. Quotations without proper certificate will be rejected.
- 3. Bidders should quote their rates in their letterhead based on the above mentioned specifications and requirements with official stamp and signature.
- 4. The rates quoted should be inclusive of all but excluding taxes, which should be stated separately.
- 5. The rates quoted should be valid for two months from the issuance of the letter inviting quotation.
- 6. Training for the Software (in house / online) shall be of at least 2 days.
- Satisfactory Performance Certificate towards the SITC of the Software from at least 2 organizations may be provided with the quotations.

- 8. Warranty / Service Support / Technical Support: 1 (one) year from the date of completion of SITC of the Software without any extra charges.
- 9. Performance Security: Successful Bidder must submit Security Deposit in the form of Demand Draft or Performance Bank Guarantee @ 3% of the value of the Work Order within 3 days from the issue of Work Order with the validity of 14 months. If the Seller fails or neglects to observe or perform any of his obligations under the contract it shall be lawful for the Buyer to forfeit either in whole or in part, the Performance Security furnished by the Seller.
- 10. Liquidated Damage: SITC of the Software should be completed within 03 days from the date of the Work Order failing which LD @ 0.5% per week or part of the week may be imposed upto a maximum of 10% of the value of the Work Order.
- 11. Submission of multiple bids by a single firm will lead to rejection of the bids and IMU-KC may black list such firms from future participation.
- 12. Last date of submission of quotation is 20.03.2023.
- 13. E-invoicing is mandatory as per Notification No. 61/2020 Central Tax dated 30.07.2020.

- 15. The envelope should be addressed to the Dy. Registrar, Indian Maritime University, P 19, Taratala Road, Kolkata 700 088 and deposited in the Tender Box kept at the Dy. Registrar's office (1st floor, Room No. 130) or can be sent by post.
- 16. The envelopes are to be sealed properly with gum and not by stapler pin.
- 17. Payment will be made through NEFT upon submission of the bill / invoice after successful completion of the work certified by the competent authority of IMU-KC.
- 18. Evaluation would be done based on L1 amount quoted by the prospective firms.
- 19. Notwithstanding anything specified in this letter inviting quotation, IMU-KC at its sole discretion, unconditionally and without assigning any reason, reserves the right:
 - (a) To accept or reject lowest bid or any other bid or all the bids.
