- 1. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration
- 2. AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

1. Supply of Equipment: -

The supply shall include complete set of equipment including accessories, spares an d consumables as described along with the pedestal for easy accessibility for the trainee.

The equipment shall be compatible with 220 V-240 V, 50 Hz, single phase ac power supply. If any power adapters are required, those shall be part of the supply from the supplier.

2. Installation, Demonstration and User Acceptance Testing:

- 2.1. The supplier is required to supply the items within 45 days of the issuance of the work order and do the installation and demonstration of the equipment within 15 days of the arrival of materials at the IMU's site of installation; oth erwise the penalty clause will be the same as per the supply of materials.
- 2.2. The successful Bidder shall depute their Service Engineer for demonstration /calibration /conduct of demo experiments of the equipment.
- 2.3. The acceptance tests for supplied goods shall be carried out at IMU by the su pplier with the participation of concerned personnel from IMU-MPC.
- 2.4. The supplier shall provide necessary consumables till the completion of accept ance testing, without any additional cost.
- 2.5. All parts and equipment should be brand new and unused. Refurbished item s shall not be accepted.
- 2.6. The equipment shall be robust for academic use and shall have to produce r esults with accuracy, as determined reasonable by IMU.

3. Acceptance of Equipment:

- 3.1. The activity shall deem to have been completed with the completion of Suppl y, Installation, Servicing, Repairs and putting in operations fully functional s ystem as per requirements of IMO/ DGS. However, the supply shall be comp lete only upon certification to this effect issued
- 3.2 Upon completion of Supply / work and after successful completion of other pr erequisites like acceptance testing, Training etc., as prescribed in this docu ment, IMU shall receive a written undertaking from the supplier that the su pply / works have been completed and accordingly a certificate of completi on would be issued in respect of the supply/works. The warranty period for t he supplied system would commence from the date of system being completely operational and functional as per the standards of IMO/ DGS.
- 4. Replacement of Defective Equipment: If any of the equipment supplied by the supplier is found to be substandard, refurbished, un-merchantable or not in accordance with the description/specification or otherwise faulty, the IMU will have the right to reject the equipment or its part. The prices of such equipment shall be refunded by the supplier with 18% interest per annum if such payments for such equipment have already been made. All damaged or unapproved goods shall be returned at suppliers cost and risk and the incidental expenses incurred thereon shall be recovered from the supplier. Defective part in equipment, if found before installation and/or during warr anty period, shall be replaced within 30 days on receipt of the intimation from this office at the cost and risk of supplier including all other charges. In case supplier fails to replace above item as per above terms & conditions, IM U may consider 'Banning' the supplier and any other remedies, as deemed fit by IMU-MPC.
- 10. Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 11. **Consortium:** In case of Contracts, wherein the seller alone does not have necessary expertise, the seller can form consortium with other sellers for submission of the bid, with one of the consortium company as leader. However, each and every member of the consortium shall be equally responsible for the complete

- execution of the project contract. An undertaking to this effect is to be uploaded with bid.
- 12. Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.
- 13. Malicious Code Certificate:

The seller should upload following certificate in the bid:-

- (a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :-
 - (i) Inhibit the desires and designed function of the equipment.
 - (ii) Cause physical damage to the user or equipment during the exploitation.
 - (iii) Tap information resident or transient in the equipment/network.
- (b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.
- 14. **Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid
- 15. **PAYMENT OF SALARIES AND WAGES:** Service Provider is required to pay Salaries / wages of contracted staff deployed at buyer location first i.e. on their own and then claim payment from Buyer alongwith all statutory documents like, PF, ESIC etc. as well as the bank statement of payment done to staff.

 - 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
