INVITATION FOR BIDS:

The Indian Maritime University Kolkata (hereinafter referred to as the Buyer or IMU KC) invites tenders for "REFURBISHMENT OF EXISTING 3-PASS HORIZONTAL SMOKE TUBE CT BOILER AT INDIAN MARITIME UNIVERSITY, KOLKATA CAMPUS" – ON PROPRIETARY ARTICLE CERTIFICATE (PAC) BASIS UNDER SINGLE COVER SYSTEM THROUGH OFFLINE MODE.

Overall Scope and objective of this Tender is to select a successful bidder for dismantling the old set ups, transferring the old set ups to a designated place (as per IMU KC), reinstallation of items from old set ups, and entire refurbishment of existing 3 pass Horizontal smoke tube CT Boiler and IBR Certification thereof including installation of Industrial RO plant along with 05 years Post- Non Comprehensive warranty. This Clause needs to be qualified with details of either the Drawings of our Workshop or requirements of dismantling and refurbishment of the existing Boilers including its Foundations and associated Civil Works.

1.1. Eligibility Criteria:

The bidder should have mandatory qualifications as per the following table. The offer will be rejected if the bidder does not fulfil any one of the mandatory qualification criteria.

S No	Qualification Criteria	Supporting documents
1.	The Bidder should have a valid PAN and GST Registration Certificate.	Copy of the PAN Card and GST registration certificate.
2.	The Bidder shall be the Original Equipment Manufacturer (OEM) Certification or OEM Authorisation of the existing Boiler. He shall furnish necessary the OEM indicated in this tender and confirming that necessary assistance would be provided to him in providing required support during the Warranty Period and Post Warranty period.	OEM Certification or OEM Authorisation as per the Annexure. In case of participation by OEM, self-declaration along with OEM registration. Payments will be made only in INR and there shall be no FE component. Boiler Components, if any, or Spare Parts, if any, which are imported should be specifically mentioned and supportability of the same should be guaranteed for the next 30 years. Up-gradations, if any, should happen at OEM's Cost.
3.	The Bidder should not have been debarred country wide so far.	Self-declaration to this effect.

1.1.1. With regard to the various proof/supporting documents produced by the bidders for establishing that they meet the various eligibility conditions, it shall be IMU's

prerogative to decide whether the document produced is valid evidence or not and to call for additional proof, if required.

1.1.2. All the Mode of Proof Documents for meeting eligibility criteria enclosed with the tender are to be duly signed by the authorized signatory. If required, IMU-KC may insist for notarized copy or ask to produce originals to ascertain the veracity of the documents. IMU-KC also reserves the right to ask more proof to corroborate the eligibility declarations.

QUALIFYING CONDITIONS:

Only OEM or OEM Authorised of the Existing Boiler in the Workshop, IMU KC.

1.2. Language of Proposal & Correspondence:

The tender, and all correspondence and documents, related to the tender, exchanged between the bidder and IMU KC should be in the English language only. If the bidder along with their offer furnish any printed literature written in any other language, such documents should be supplemented with their English translation also. The contents in the English translated version alone shall be taken into consideration.

1.3. Tender Validity:

- **1.3.1.** Tenders shall remain valid for **90 days** from the last date for submission of tender. An offer valid for a shorter period may be rejected by IMU KC as being non-responsive. During the period of validity of offer, the terms and condition mentioned shall not change and any such request may lead to denial of the award.
- 1.3.2. In exceptional circumstances, prior to the expiry of the original tender validity period, the IMU KC may request the bidders to extend the period of validity for a specified additional period. The request and the response thereof shall be made in writing through E-mail or Post. A bidder agreeing to the request will not be required to nor permitted to modify his tender, but will be required to extend the validity of his tender for the period of extension. In case a bidder is not agreeing to the request of the IMU for extension of validity of the tender, then his tender will not be processed further and the portions of his tender which have not been opened will be returned to them unopened as the case may be. The EMD paid by them will also be refunded to them as in the case of other unsuccessful bidders.

1.4. Proposal prices:

The prices indicated in the price schedule shall be entered in the following manner:

i) The total price quoted must be inclusive of freight and insurance up to dismantling, shifting, re-fixing of old items, and entire refurbishment of existing 3 pass Horizontal smoke tube CT Boiler including installation of Industrial RO plant along with 05 years Post- Comprehensive warranty including testing, commissioning and Certification.

- ii) Prices quoted as above shall be valid for a minimum period of 90 days from last date for submission of the tender.
- iii) It must be clearly understood that the prices quoted in the tender are to include everything required to be done as per the specification and the conditions of tender and supply for the proper execution of supply/works although special mention thereof may have been omitted in the specification. The specifications indicated are for minimum and shall include accessories etc. to make the system fully operational. IMU KC has the right to change /increase / withdraw the quantities of any items in the tender prior to acceptance by the supplier of the work order issued by IMU KC.

1.5. Submission of the Proposal:

The tender submitted by the Bidder shall comprise the following and should be read in conjunction with any Amendments issued at the time of submission of bid. Clause wise Compliance Statement is to be submitted as part of the Bid.

1.5.1. Techno-commercial Bid:

- i) General / Administrative Documents
 - a. Covering Letter on OEM letterhead, stating willingness to undertake the refurbishment work at IMU Kolkata on PAC basis.
 - b. Authorization Letter / Certificate –If the bid is submitted by an authorized service partner/dealer, OEM must issue a current authorization letter permitting them to quote and execute the work.
 - c. Valid OEM Registration Certificates (such as ISO/CE/ISI, if applicable).
 - d. GST Registration Certificate.
 - e. PAN Card copy of the OEM or authorized bidder.
 - f. Bank Account Details Cancelled cheque and bank mandate form for payment purposes.

ii) Technical Documents

- a. Technical Compliance Sheet / Scope Confirmation confirming the scope of refurbishment as per IMU's requirements.
- b. OEM Warranty Declaration confirming the warranty period after refurbishment
- c. Certification confirming compliance with applicable IBR/Boiler regulations.
- iii) Financial Documents (in same cover)
 - a. Price Bid / Quotation in OEM letterhead, duly signed and sealed as per Price format in Annexure.

iv) Declarations / Undertakings

- a. Undertaking that the quoted work and parts are OEM-supplied / genuine.
- b. Undertaking that the price quoted is the lowest and not higher than the OEM's standard rate for government institutions and Price Reasonability Certificate and Fall Clause.
- c. Undertaking for timely completion of work within the agreed schedule.

1.6. Cost of Bidding:

The bidders shall bear all costs, efforts or their time associated with the preparation and submission of their bids and the IMU KC will in no case be responsible or liable for those costs / efforts / time, regardless of the conduct or outcome of the tendering process or the cancellation, if any, of tender by IMU KC, due to any reason whatsoever and at any stage of the tender (IMU KC is not responsible, if there is a cancellation even after Financial bid opening).

1.7. Completeness of Tender:

The Bidder is expected to examine all instructions, forms, terms, conditions and deliverables in the tender document. Failure to furnish all information required by the tender documents or submission of a tender offer not substantially responsive in every respect to the tender documents will be at the bidder's risk and may result in rejection of its tender offer. The tender offer is liable to be rejected outright without any intimation to the bidder if complete Information as called for in the tender document is not given therein, or if particulars asked for in the forms / proforma in the tender are not fully furnished.

1.8. Deadline for Submission of Proposals:

Tenders must be submitted through Offline Mode Only within the last date & time for submission, specified in the abstract. IMU KC may, at its sole discretion extend the date and time for submission of tenders. Any updates with regard to such extension or any other communication intended for the bidders / prospective bidders will be made only through IMU websites and CPPP E-Publishing Portal. Any tender received after the last date and time for submission of tenders prescribed will be rejected.

1.9. Late Proposal:

Any proposal received by IMU KC after the deadline for submission of proposals prescribed by IMU KC, will be rejected and kept as an unopened Tender.

1.10. Modification and withdrawal of bids:

1.10.1. The bidder may be allowed to modify or to submit revised bid due to corrigendum, addendum, etc., issued by IMU KC, any time prior to the last date prescribed for receipt of bids, by giving a written notice to the IMU KC.

- **1.10.2.** The bidder's modification or withdrawal notice shall be prepared, sealed, marked and dispatched in a manner similar to the original Proposal.
- **1.10.3.** Subsequent to the last date for receipt of bids, no modification of bids shall be allowed. No bid may be withdrawn in the interval between the deadline for submission of bids and expiration of the of bid validity period specified. Withdrawal of a bid during this period will result in Bidder's forfeiture of bid security/EMD.

1.11. IMU KC's Right to accept and to reject any or all proposals:

Notwithstanding anything else contained to contrary in this Tender Document, IMU KC reserves the right to accept or reject any Bid or to annul the bidding process fully or partially or modifying the same and to reject all Proposals at any time prior to the award of work, without incurring any liabilities in this regard.

1.12. Rejection of Bids:

The bids will be rejected on following grounds:

- **1.12.1.** If any of the eligibility criteria as per the qualification criteria is not met
- **1.12.2.** If tender terms and conditions are not met
- **1.12.3.** If bidder gives wrong information in the bid
- 1.12.4. Canvassing in any form in connection with the bids
- **1.12.5.** If the bid is incomplete /partial bid/ conditional/unclear in any form
- **1.12.6.** Bids submitted after due date and time
- **1.12.7.** Bids are submitted through Telex/Fax/ e-mail / by way of speed post/ courier
- **1.12.8.** Erasure and/or overwriting (if not countersigned by authorized person)
- **1.12.9.** Bids not signed by authorized signatory

1.13. Evaluation Process:

- **1.13.1.** IMU KC shall evaluate the responses to the Notice Inviting Tenders and all supporting documents / documentary evidence. Inability to submit requisite supporting documents / documentary evidence, may lead to rejection.
- **1.13.2.** The interpretation of the bids and the decision made by the IMU KC in the evaluation of responses to the Notice Inviting Tenders shall be final. No correspondence will be entertained outside the process of evaluation with IMU KC.
- **1.13.3.** IMU KC reserves the right to request for meetings with the bidders to seek clarifications on their bids.
- **1.13.4.** IMU KC reserves the right to reject any or all bids on the basis of any deviations.

1.13.5. Each of the responses shall be evaluated as per the criterions and requirements specified in this NIT.

1.14. Tender Evaluation:

- **1.14.1.** Technical and Financial evaluation will be made based documents submitted as requested and quoted Price inclusive of freight and insurance up to dismantling, shifting, entire refurbishment of existing 3 pass Horizontal smoke tube CT Boiler including installation of Industrial RO plant along with 05 years 3.5. Post Non Comprehensive Onsite warranty including testing, commissioning and Certification at IMU KC's Campus, excluding applicable GST.
- 1.14.2. After successful evaluation of the techno-commercial bid and financial bid, the Work Order would be awarded to the bidder/OEM.

GENERAL CONDITIONS OF CONTRACT:

2.1. Termination Clause:

- **2.1.1.** In the event of the breach of any of the provisions of contract by the supplier, IMU KC shall have the right to terminate the tender summarily, at any stage.
- **2.1.2.** In the event of IMU KC terminating the contract for breach by the supplier of any of the provisions thereof, the supplier shall be liable for any loss suffered by IMU KC up to the time of the termination of the contract.
- **2.1.3.** In the event of the supplier's breach of any provision of this contract, resulting in its termination by IMU KC, the supplier shall be held liable for any loss suffered by IMU KC up to the time of the contract termination.
- **2.1.4.** The supplier's liability for losses shall include, but not be limited to, direct damages, costs, and expenses incurred by IMU KC in connection with the breach and termination. IMU KC reserves the right to pursue any other remedies available under law or equity.
- **2.1.5.** The liability of the supplier for losses shall not exceed the total contract value at the time of termination, unless otherwise agreed upon by both parties in writing.
- **2.1.6.** The termination of the contract under this clause shall not waive or affect any other rights or remedies that IMU KC may have under this contract or applicable laws.
- **2.1.7.** Both parties acknowledge the importance of promptly notifying each other of any potential breach and working together in good faith to resolve the issues before resorting to termination."
- **2.1.8.** In the event of the death, insanity or insolvency of the supplier, IMU KC shall have the right to terminate the contract summarily and to purchase in the open market any Goods/ Services covered by the contract. In this case, the supplier shall not be liable for any excess in the price paid, for any such purchases over the tender price.
- **2.1.9.** In the event of failure to carry out the work assigned under the contract to satisfaction on IMU- Kolkata, IMU-KC reserves the right to get the work done through alternative sources, at the risk and cost of the contractor.

2.2. Security Deposit:

2.2.1. The performance security deposit @ 10% of the total contract value would be deducted from the final payment, which would be refunded not later than 60 days after completion of the total tenure of the contract and warranty obligations thereof, if any.

2.3. Delivery Period:

The Complete Refurbishment Work must be completed in 90 Days after Placement of Contract.

2.4. Liquidated Damages:

If the successful bidder fails to execute the Supply/Works in all respects within the period specified or within such extended period as may be allowed, the successful bidder shall pay a sum equivalent to 0.5% of the value of the total tender price per week (Seven days) or part thereof subject to a maximum limit of 10% of the value of the each of the item tender as liquidated and ascertained damages.

IMU KC shall have the right to determine what the "amount payable/corresponding payment" for any step/activity is, and while the Successful Bidder has a right to represent/clarify, IMU KC's determination of the same shall be final without prejudice to the Successful Bidder's rights to seek alternative remedy through arbitration/Courts.

2.5. Post- Non Comprehensive Onsite warranty:

- **2.5.1.** A Post Non-Comprehensive warranty for the supplied refurbishment of the entire equipment shall be provided by the supplier for a minimum of 5 year from the after completion of the standard warranty period. The supplier will be notified of any defect or claim arising under this warranty and the warranty support shall be provided at site of IMU KC Campuses.
- 2.5.2. If the supplier having been notified fails to rectify the defect within 7 days, IMU KC may proceed to take such remedial action as may be necessary at the supplier's expense. The period that the equipment is out of commission / operation as a result of supplier's failure to rectify the defects notified shall result in extension of the warranty period correspondingly and imposition of penalty (Rs. 10000/- per instance which will be adjusted from the Security Deposit or any other dues to the supplier).

2.6. Payment Terms:

- 2.6.1. The Tax Invoice raised by the supplier must be in compliance of relevant GST acts, rules & notifications made there under and should bear the IMU KC GST Registration no. 19AAAAI2610K1ZU. The rate and amount of CGST, SGST, IGST and GST (Compensation to State) cess, related to supply of goods, shall be shown separately in tax invoice for each item of supply.
- **2.6.2. Statutory variation:** If there is any statutory change in CGST & SGST or IGST within contractual delivery period, the same shall be admissible and will be paid at actual based on the documentary evidence. However, no upward revision in the same beyond original delivery period shall be admissible.

2.6.3. Stages of Payment are as Follows:

1.	Post Non Comprehensive Warranty	On prorata Basis for every 3 months, after commencement of Post Non Comprehensive Warranty. Note: IMU-KC have the full right to undertake or not to undertake the said Warranty but bidder must offer the price against the said warranty.

2.7. Secrecy:

The Supplier shall not transfer any part or share of his responsibilities directly or indirectly to any person whomsoever without the written consent of IMU KC.

2.8. Force Majeure:

- **2.8.1.** The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.
- **2.8.2.** For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, earthquakes, meteorite strike, quarantine restrictions and freight embargoes.
- 2.8.3. If a Force Majeure situation arises, the Supplier shall promptly notify the IMU KC in writing of such conditions and the cause thereof. Unless otherwise directed by the IMU KC in writing, the Supplier shall continue to perform its obligations under the Contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

2.9. Indemnity:

The selected bidder shall indemnify IMU KC from and against any costs, loss, damages, expense, claims including those from third parties or liabilities of any kind how-so-ever suffered including patent, copyright, trademark and trade secret, arising or incurred during and after the Contract period out of:

- **2.9.1.** Negligence or wrongful act or omission by the Selected Bidder or its team or any Agency/ Third Party in connection with or incidental to this Contract; or
- **2.9.2.** Any breach of any of the terms the Selected Bidder's Proposal as agreed, the Tender and this contract by the Selected Bidder, its Team or any Agency/Third Party.
- **2.9.3.** Bidder (the "Indemnifying Party") undertakes to indemnify the client (the "Indemnified Party") from and against all losses, claims for damages including losses, claims for damages on account of bodily injury, death or damage to tangible.
- **2.9.4.** The indemnity shall be to the extent of 100% of project cost in favour of the IMU KC.

2.10. Arbitration & Jurisdiction:

Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration administered by the India International Arbitration Centre ("IIAC") in accordance with the India International Arbitration Centre (Conduct of Arbitration) Regulations ("IIAC Regulation") for the time being in force, which regulation are deemed to be incorporated by reference in this clause.

The place/seat of the arbitration shall be Kolkata India

The Tribunal shall consist of three arbitrators.

The law governing the arbitration agreement shall be Indian Law.

The language of the arbitration shall be English.

Applicable Law:

The governing Law of the contract shall be Indian Law.

2.11. Code of Integrity:

The bidders/suppliers should sign a declaration about abiding by the Code of Integrity for Public Procurement in bid documents. In case of any transgression of this code, the bidder is not only liable to be removed from the list of registered suppliers, but it would be liable for other punitive actions such as cancellation of contracts, banning and blacklisting or action in Competition Commission of India, and so on.

- **2.11.1.** Code of integrity for Public Procurement: The Purchaser as well as bidders, suppliers, contractors and consultants should observe the highest standard of ethics and should not indulge in the following prohibited practices, either directly or indirectly, at any stage during the procurement process or during execution of resultant contracts:
- i) "Corrupt practice": making offers, solicitation or acceptance of bribe, rewards or gifts or any material benefit, in exchange for an unfair advantage in the procurement process or to otherwise influence the procurement process or contract execution;
- ii) "Fraudulent practice": any omission or misrepresentation that may mislead or attempt to mislead so that financial or other benefits may be obtained or an obligation avoided. This includes making false declaration or providing false information for participation in a tender process or to secure a contract or in execution of the contract;
- iii) "Anti-competitive practice": any collusion, bid rigging or anti-competitive arrangement, or any other practice coming under the purview of the Competition Act, 2002, between two or more bidders, with or without the knowledge of the purchaser, that may impair the transparency, fairness and the progress of the procurement process or to establish bid prices at artificial, non-competitive levels;
- iv) "Coercive practice": harming or threatening to harm, persons or their property to influence their participation in the procurement process or affect the execution of a contract:
- v) "Conflict of interest": participation by a bidding firm or any of its affiliates that are either involved in the consultancy contract to which this procurement is linked; or if they are part of more than one bid in the procurement; or if the bidding firm or their personnel have relationships or financial or business transactions with any official of purchaser who are directly or indirectly related to tender or execution process of contract; or improper use of information obtained by the (prospective) bidder from the purchaser with an intent to gain unfair advantage in the procurement process or for personal gain; and
- vi) "Obstructive practice": materially impede the purchaser's investigation into allegations of one or more of the above mentioned prohibited practices either by deliberately destroying, falsifying, altering; or by concealing of evidence material to the investigation; or by making false statements to investigators and/or by threatening, harassing or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or by impeding the purchaser's Entity's rights of audit or access to information;

SCOPE OF WORK:

3.1. Scope of Work: The flowing works are under the scope of Bidder.

- 1. Opening and Inspection after removing the insulation.
- 2. End Plates checking with gauging.
- 3. Dismantling of all Tubes (all 3 Passes)
- 4. Checking & gauging of tube plates (2).
- 5. Checking and gaging of Furnace.
- 6. All Mountings to be dismantled, serviced and make it working condition.
- 7. Fixing of new tubes (all 3 pass tubes) IBR Certified.
- 8. New Burner installed for LOO and HSD both.
- 9. Hydraulic pressure test after changing tubes.
- 10. Checking & replacement of electrical control panel devices, safety switches, alarms and trips.
- 11. Overhauling of Feed Pump, Fuel Tank, Fuel Pump, FD fan etc. thoroughly checking, oiling, greasing of all parts.
- 12. Painting, Insulation, Re-factory change of Gaskets etc.
- 13. Cleaning, Painting, filling of LDO with electrical operated pump to be fixed. So that pump will lift the LDO for oil service tank.
- 14. Replace the Mabray, Safety Valves with easing gear etc.
- 15. Chemical dosing to be done with tank & pump including chemical.
