Sealed quotations are invited towards undertaking the Structural Audit for old building (A-Type Quarter & 240 Seater Hostel including East Wing, West Wing, Mess and Dining) of Indian Maritime University – Kolkata Campus, located at P-19, Taratala Road, Kolkata – 700088 with the following scope of work:

- A. NDT testing of the buildings which includes the following:
 - i. Rebound Hammer Test: 25 nos.
 - ii. Ultrasonic Pulse Velocity Test: 25 nos.
 - iii. Rebar Profometer: 10 nos.
 - iv. Half Cell Potentiometer: 04 nos.
 - v. Core Cutting Test: 04 nos.
 - vi. Chemical Analysis: 04 nos.
 - vii. Depth of Carbonation: 04 nos.
- B. Preparation of building-wise report along with recommendations.

Prospective bidders are requested to submit their quotations in the format in Annexure - I complying with the above mentioned scope of work and the following terms and conditions.

Terms & Conditions:

- 1. Bidders should quote their rates as per the format in Annexure I on their letterhead with official stamp and signature.
- 2. Bidder should submit the Price Reasonability Certificate as per the format in **Annexure II** along with their quotations.
- 3. Bidders must submit the following documents along with their quotations:
 - a. Copy of work completion certificate / work order for undertaking similar work in any Government / PSU / Autonomous Body / Statutory Organization / Universities.
 - b. Certification from National Accreditation Board for Testing and Calibration Laboratories (NABL), MoU or Collaboration with NABL / Similar Laboratories.

***(Failing in submission of the above mentioned documents, the submitted quotations by the prospective bidders will summarily be rejected).

- 4. Prospective bidders may visit the office of IMU-KC on any working day (Monday to Friday) between 10:00 A.M. and 5:00 P.M. before submission of their quotations.
- 5. The rates quoted should be inclusive of all but excluding taxes, which should be stated separately.
- 6. E-invoicing is mandatory as per Notification No. 61/2020 Central Tax dated 30.07.2020.
- 7. The rates quoted should be valid for two months from the issuance of the notice inviting quotations.
- 8. The work should be completed within 01 (one) month of placing order, failing which LD @ 0.5% per week or art of the week may be imposed upto a maximum of 10% of the value of the Work Order.
- 9. Submission of multiple bids by a single firm will lead to rejection of the bids and IMU-KC may black list such firms from future participation.
- 10. Last date of submission of quotation is 07.01.2026.
- 11. The quotation is to be submitted in sealed envelope clearly subscribing "Quotation towards Structural Audit for Old Buildings (A-Type Quarter & 240 Seater Hostel including East Wing, West Wing, Mess and Dining) of IMU Kolkata Campus".
- 12. The envelope should be addressed to the Campus Director, Indian Maritime University, P 19, Taratala Road, Kolkata 700 088 and deposited in the Tender Box kept at the office of Director's Secretariat (1st floor, Room No. 124) or can be sent by post.
- 13. The envelopes are to be sealed properly with gum and not by stapler pin.
- 14. Evaluation would be done based on the L1 in total amount quoted by the prospective firms.
- 15. Payment will be made through NEFT after successful completion of the work duly certified by the designated official of IMU-KC.
- 16. Notwithstanding anything specified in this letter inviting quotation, IMU-KC at its sole discretion, unconditionally and without assigning any reason, reserves the right:
 - (a) To accept or reject lowest bid or any other bid or all the bids.
 - (b) To accept any bid in full or in part.
 - (c) To reject the bid offer not conforming to the tender conditions.
