- d) Community Certificate as per IMU Format (OBC – Non-Creamy / SC / ST)
- e) Transfer Certificate or Migration Certificate
- f) Printed copy of IMU's Rank Certificate
- g) Medical Fitness Certificate (DGS-approved Doctor)
B.Tech: Distance Vision unaided 05* (6/12) in each eye or 0.67 *(6/9) in one eye and 0.33*(6/18)in another eye.
BSC, DNS: Eyesight 6/6 in each eye or 6/6 in one eye &6/9 in the other eye (No color blindness in the eye)
- h) Aadhaar Card
- i) **A passport is Mandatory before joining the Campus.** (If it is not readily available, apply immediately on Tatkal)
- j) Passport Size photos (08 Nos.) (Size: 3.5 * 3.5 Cms) (Front view with both ears visible, clean-shaven and proper haircut, light-colored formal shirt/ coat (as shown) and white background. T-shirts, checkered/ striped prints, and Casual Shirts are not allowed.
- k) One set of self-attested copies of all documents.
- l) Domicile certificate for candidates allotted seats reserved for the North Eastern States, J & K, Andaman & Nicobar Islands, and Lakshadweep Islands.
- m) To bring an EWS certificate required for applying for any scholarship

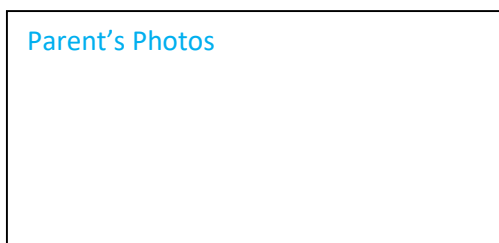
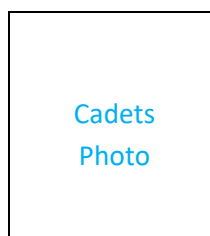


