- h) Aadhaar Card
- i) A passport is Mandatory before joining the Campus. (If it is not readily available, apply immediately on Tatkal)
- j) Passport Size photos (08 Nos.) (Size: 3.5 * 3.5 Cms) (Front view with both ears visible, clean-shaven and proper haircut, light-colored formal shirt/ coat (as shown) and white background. T-shirts, checkered/ striped prints, and Casual Shirts are not allowed.
- k) One set of self-attested copies of all documents.
- I) Domicile certificate for candidates allotted seats reserved for the North Eastern States, J & K,Andaman & Nicobar Islands, and Lakshadweep Islands.
- m) To bring an EWS certificate required for applying for any scholarship
