- Sub Implementation of policy for Academic Progression for the students admitted from the Academic Year 2024-2025 – Reg.

The Executive Council in its 78th Meeting held on 05.07.2024 vide Agenda No.EC 2024-78-03 has resolved to implement the policy for Academic progression for the students admitted from the Academic Year 2024-2025 as recommended by the Academic Council vide Agenda No.2024-42-03 during its meeting held on 03.07.2024 as detailed below:

- (a) If a student who has arrears in the first year of a programme (i.e. 1st and 2nd Semester), he/she cannot proceed into the third year (i.e. 5th Semester)
- (b) If a student who has arrears in the second year of a programme (i.e. 3rd and 4th Semester), he/she cannot proceed to the fourth year (i.e.7th Semester)
- (c) Such students will have to clear the arrear papers as external candidates (cannot attend classes and will not be permitted to stay in hostel)
- (d) Such students after clearing arrears, can re-join the course at appropriate batch with regular students after paying applicable semester fees.
- (e) One/Two year programmes are exempted from this policy
- (f) **This policy will come into effect for the batches admitted from August 2024 onwards (i.e. from the Academic Year 2024-2025)**

2. All Campus Directors and Principals of Affiliated Institutes are requested to sensitise the first year students about the above policy of the academic progression during the induction/orientation ceremony, as the case may be, on the first day when they join from the Academic Year 2024-25 onwards.
3. **IMU Circular 1917, dt.30.07.2019 is hereby repealed.**
