**ADDENDUM TO CIRCULAR NO. 2402 DATED 31.01.2024**

- Sub Regulations for Introduction of absolute grading method under Common Choice Based Credit Systems (CBCS) across all the Schools - Rule for awarding 1<sup>st</sup> Division with Distinction, 1<sup>st</sup> Division and 2<sup>nd</sup> Division – Addendum to Circular 2402 – Regarding
- Ref (1) IMU Circular 1652, dated:23.12.2016  
(2) IMU circular 2402, dated:31-01-2024

1. Please refer IMU's Circular No 2402 dated 31-01-2024 regarding Regulations for introduction of absolute grading method under Common Choice Based Credit System (CBCS) across all the Under-Graduate and Post-Graduate Programmes for the Academic Year 2024-2025 and for School of Maritime Management Programmes from the Academic Year 2022-2023 onwards.
2. The following addendum to IMU Circular 2402 as para 1(p) regarding Rule for awarding 1<sup>st</sup> Division with Distinction, 1<sup>st</sup> Division and 2<sup>nd</sup> Division is hereby promulgated as follows: -

(1)	A student shall be awarded ' <b>1<sup>st</sup> Division with Distinction</b> ', if he/she has secured a CGPA of 8 or more in the aggregate and has passed all the <b>subjects in the first attempt itself.</b>
(2)	A student shall be awarded ' <b>1<sup>st</sup> Division</b> ', if he/she has secured a CGPA of 6.5 or more and less than 8 in the aggregate even if has failed in one or more subjects <b>provided he has passed all the subjects within the stipulated duration (1/2/3/4-year) of the programme.</b>
(3)	A student shall be awarded ' <b>2<sup>nd</sup> Division</b> ', if he/she has secured a CGPA of less than 6.5 in the aggregate.
(4)	A student shall be awarded ' <b>2<sup>nd</sup> Division</b> ', if he/she has secured a CGPA of 6.5 or more in the aggregate clearing all subjects after the stipulated duration of (1/2/3/4-year) of the programme.



3. This shall come into force from the Academic Year 2024-25 onwards for all the students admitted in August 2024 for all the schools except SMM. For SMM this shall, come into effect retrospectively from the Academic Year 2022-23 onwards for the students admitted in August 2022.
4. This issues with the approval of the Vice Chancellor.
