Sub- Procedure to be adopted for admissions to DNS Course leading to B.Sc. (Applied Nautical Science) by the Affiliated Institutes for August 2025 Batch - Confirmation on sponsored seats-reg.

Ref: 1. DGS Circular No. 6/2013 dated 30.04.2013.

The institutes affiliated to Indian Maritime University for conducting DNS programme leading to B.Sc. (Applied Nautical Science) are required to take the following points into consideration before admitting candidates to the said programme:

- 1. All the Affiliated Institutes conducting DNS Course leading to B.Sc. (Applied Nautical Science) will be required to make the necessary tie-ups for on-board training for the candidates to be admitted, with Ship-owning companies/ship-managing companies/ RPSL agencies. The number of slots for which the sponsorship is available should be forwarded by Affiliated Institutes to IMU on or before 20.06.2025 in the format prescribed on their official letter- head signed by the Authorised Signatory.
- 2. The Affiliated Institutes should acquire the necessary sponsorship letters from the Ship-owning companies/Ship-managing companies/RPSL genies on official letter-head of the sponsoring company/agency duly signed by the authorized signatory, indicating the number of sets sponsored for that particular Institute. They should send the photo copies of the sponsorship letters to the Deputy Registrar (Academics), Indian Maritime University, Chennai along with scanned copies of the sponsorship letters to dracademics@imu.ac.in and a copy to academicscell@imu.ac.in.
- No Affiliated Institute should make any admissions to DNS 3. programme without obtaining these sponsorship letters. Hence, institutes are requested to make necessary arrangements well in advance to avoid unnecessary delay in admission/allotment.
