Sub: Procedure for data entry and certificate verification – Affiliated Institutes-Academic Year 2025-26.

Ref: UG (Except BBA) –Provisional Rank List- Published in IMU Website on 30.05.2025

Madam / Sir,

- 1. IMU-CET 2025 results were published on IMU website on 30.05.2025.
- 2. Candidates qualified in IMU-CET fulfilling the eligibility criteria relating to age, educational qualifications, and medical fitness as per IMU norms are eligible for admissions to the Programmes offered in IMU Campuses and its Affiliated Institutes for the Academic Year 2025-26.
- 3. The Procedure for certificate verification and related details are mentioned as follows:

a. Online Entries on Web based Software:

For entering the details of candidates selected by Affiliated Institutes, data entry portal will be opened from **08-07-2025 till 11.07.2025**. It shall be the responsibility of the Affiliated Institute concerned to upload the details of the students admitted in the portal through their respective login. Further they are required to send the original certificates and medical certificates of their candidates for verification through the representative to the designated IMU Campus. At the designated IMU Campus, these online entries will be verified with reference to the Original Certificates, Medical Certificates etc. **No 'Admission Registration Number' will be allotted to the candidates unless the above formalities are fulfilled**.

b. <u>Online Payment of Admission Registration Fee and Programme Fee:</u>

After the data submission, Admission Registration fee and the programme fees payment have to be done by the candidates individually through a login through which the candidates will be able to do the payment. The credentials and time schedule for payment will be intimated in due course of time.

c. Verification Process:

Affiliated Institutes must make sure that all their candidates have made online payment of Admission Registration Fee of Rs. 10,000/-(Non-Refundable) and Programme Fee of Rs. 30,000/-(Non-Refundable) totalling Rs. 40,000/-(Non-Refundable) per candidate. **Only those candidates whose payments are received shall be verified at the designated campuses.**

Affiliated Institutes' representative (at the rank of Officer / Faculty) will have to report to the Director of the designated IMU Campus along with the authorisation letter and identity card for verification process, on the date mentioned against the Institute as given below:

<u>Certificate Verification will not be done other than the scheduled date.</u> <u>No extension will be given.</u>

Verification will be done as per schedule mentioned above between 10.30 a.m. and 5.00 p.m. Affiliated Institutes should ensure that this work is completed for all their students positively on these scheduled days. The list of Original Certificates and Medical certificates to be produced for verification in respect of each candidate is given here in under:

- Proof of Age Birth Certificate/SSLC or equivalent mark sheet.
- Higher Secondary School or equivalent mark sheet.
- Community Certificate [only for ST, SC and OBC (NCL)]/ Gen-EWS, if applicable.
- Printed copy of IMU's CET Rank Certificate. Candidates who are shown as qualified in reserved category (SC/ST) in the rank certificate, should be accompanied with a valid SC/ST certificate.
- Photocopy of Aadhar Card.
- Medical Fitness Certificate from a registered Medical Practitioner.

d. Medical Fitness Certificate

Candidates selected for Diploma in Nautical Science, B.Sc (Nautical Science) and B.Tech (Marine Engineering) should produce a Medical Fitness Certificate with confirmation of eye sight fitness from a panel of Doctors/ Hospitals approved by the Director General of Shipping, Mumbai.

4. Lateral Entry Admission & Verification – It is informed that vide IMU Circular 2510 dated 02.05.2025 initial intimation for lateral entry admissions were issued. This year the classes for lateral entry & all First/Second/Third/Fourth year students will commence on 01.08.2025. Affiliated Institutes will have to do the certificate verification at their designated IMU Campuses as indicated in the table at para 3.C. The verification for lateral entry will be done offline. All Affiliated Institutes should be ready with required documents and DD's handy on above scheduled dates (IMU may ask the students to pay online in place of DD). The admissions of the lateral entry candidates will be provisional till the time original certificates are shown at the campus.

- 5. The details of the lateral entry candidates to be admitted will be submitted to CoE with CC to DR-Academics & AR-Academics by 22-07-2025 in the attached excel sheet (Annexure II) in soft copy. There will not be any extension in the submission date.
- 6. Campuses are requested to furnish a Daily Report by 6PM regarding number of candidates verified in the proforma enclosed (Annexure-I) by email to coe@imu.ac.in with a copy to dracademics@imu.ac.in and aracademics.hq@imu.ac.in.
